ABSTRACT SUBMISSION DETAILS

General Information

- Abstracts may highlight original research, quality improvement projects, evidence-based practice, or programmatic innovations. Projects may be ongoing.
- Submissions from nurses working in all areas including academia, long-term care, public health, and community health are strongly encouraged.
- By submitting an abstract, the individual/team is agreeing that at least one person will register for, attend, and present at the Symposium.
- Presenters are responsible for their own expenses related to attending the Symposium including travel accommodations. Symposium registration is free.
- Presenters will be asked to identify any potential conflict of interest related to the content to be offered (e.g., commercial interest, affiliation with a vendor, and/or receipt of royalties) and affirm that their abstract presentations will not be used to sell a particular product or service. HSCN exerts the right to rescind the acceptance of an abstract due to any conflict of interest discovered after the fact.
- If accepted, a digital copy of your presentation (.ppt) or poster and any other presentation materials, will need to be submitted to the conference planning committee.

Abstract Requirements

- Target Audience - List audience members that might benefit most from your presentation (i.e. clinicians, nursing faculty/educators, nursing leadership, etc).
- Learning Outcome(s) - Provide at least one outcome you expect learners to achieve as a result of attending your presentation. Outcomes should be measurable. See the [Revised Bloom's Taxonomy](#) for assistance.
- Elevator Pitch - **Max. 250 characters (with spaces)**. Provide a compelling elevator pitch for your session. Summarize the focus of your presentation telling the audience what they will learn by attending your session.
- Narrative - **Max. 3000 characters (with spaces)**. The narrative should include a description of your scientific study including purpose/need, background, method/procedure, results/outcomes, and implications/conclusions.
- Evidence - Provide a complete reference list for your presentation (APA style).
